Present: Supervisor Marty Mason, Councilman Dan Wiley, Councilman Alan Wood, Mayor Jerry Golden, and one visitor.

Absent: Councilman Tim Maloney, excused, Councilman Paul Aubertine, excused.

Supervisor Mason opened the meeting at 6:30pm with the pledge of allegiance.

The board spoke with Attorneys Dave Ferrara and Brody Smith with the Bond, Schoeneck, and King law firm via zoom. The Attorneys gave an overview of their field of expertise, the length of time with the firm, and the clients they have in Jefferson County.

The board, individually asked questions of each attorney. The highlighted points being: having matters done in a timely manner; their availability; fee structure; that the board would like to have a long-standing relationship.

The board then spoke with Attorney Jim Burrows with Kendall, Walton and Burrows. Mr. Burrows appeared in person. Mr. Burrows gave an overview of his expertise, stating he has worked in the field of municipal law for many years. He talked about some of the issues that town and villages deal with that he could help the board with.

The board individually asked questions of Mr. Burrows. The highlighted points being: having matters done in a timely manner; his availability; fee structure; that the board would like to have a long-standing relationship.

Tim White gave an update on the Club Street project. He said that he has requisition requests that need to be signed by the Supervisor so that he would submit them for payment. He also reviewed other purchase orders. Tim told the board that there are a lot of items that need to be submitted with the requests. Tim also told the board that he wants the boathouse down before May and that he spoke with Bill Pond and the highway department will help with the construction of the bathhouse.
